### MINUTES IOWA LOTTERY COMMISSION

March 25, 2025 10:30 a.m.

The Iowa Lottery Commission convened at 10:30 a.m. at Lottery's main office in Clive; Commission Chair Dana Wingert presiding.

#### **CALL TO ORDER**

Wingert called the meeting to order at 10:30 a.m. and roll was taken. There was a quorum. Wingert announced the meeting would be held via teleconference in accordance with lowa Code section 21.8.

Cook moved to conduct the meeting via teleconference. New seconded. Motion carried unanimously.

#### **APPROVAL OF AGENDA**

Conneally moved to approve the agenda for the meeting. Cook seconded. Motion carried unanimously.

#### **APPROVAL OF MINUTES**

Rathje moved to approve the December 18, 2024 Commission meeting minutes. New seconded. Motion carried unanimously.

#### **DIRECTOR'S REMARKS**

Mosiman informed the Commission that both chambers of the legislature passed a bill prohibiting Department of Revenue employees from playing lottery games and anticipates the Governor will sign the bill. Once the Governor signs the bill, IDR will launch a plan to communicate and collect the necessary information from all IDR employees not currently on the prohibited player list by July 1, 2025.

#### **CEO REPORT**

Strawn gave a CEO report. Following three solid months of sales in December - February, the lottery continues to outpace budget projections for FY25 sales and proceeds. Through February, total FY25 lottery sales of \$291,913,031 are ahead of budget projections by 7.88%. Through February, total FY25 proceeds of \$60,235,419 are ahead of budget projections by 18.69%. And, through February, total FY25 lottery operating expenses of \$9,514,782 are below budget projections by 8.8%.

Performance of lottery product categories remains a mixed bag through the first 8 months of the fiscal year. Compared to last year's actual sales through the same time period:

- InstaPlay sales are up by 14.13%
- Pull Tab sales are up by 21.43%
- Lotto America sales are up by 20.19%
- Mega Millions sales are down by 21.31%
- Powerball sales are down by 53.92%
- Scratch ticket sales are down by 4.32%

As the final quarter of the fiscal year approaches, these product sales trends will likely continue. The greatest variable of the last quarter will be the performance of the national jackpot games of Powerball and Mega Millions, whose sales performance will be largely determined by the size of the grand prize jackpots. Historically, scratch ticket sales performance is more closely tied to consumer sentiment and broader external economic conditions.

To illustrate the broader challenges facing lottery, which is a discretionary, entertainment product, during a recent quarterly earnings call, one chief executive of a retailer with a very significant lowa presence noted "More discretionary items ... is where we see a little bit of softness." This is consistent with public earnings reports from leading national retailers that store traffic is down to start the calendar year. This also tracks with national research from Ipsos that found the number of Americans who say they are comfortable with their personal economic situation has dropped 14 percentage points since late last year. While another leading national consumer sentiment research report showed that consumer sentiment across all demographic groups has slumped to its lowest level in over two years. Although Iowa is not immune to these trends, it's anticipated the Iowa Lottery will continue to meet and slightly exceed its projected revenue targets, both sales and proceeds, for FY25.

Strawn also provided a few operational updates. In addition to the lottery game play prohibition on all IDR employees passed by both chambers earlier this year, two additional items proposed by the Lottery Division are also focused on safeguarding the public's trust in the Iowa Lottery.

The first relates to the Lottery's ability to keep sensitive game and ticket inventory data confidential. The proposed change would not impact the public availability of lottery game rules, overall game odds, and prizes remaining to be won for each game in the market. It simply ensures the Lottery's ability to prevent the potential manipulation of lottery games by third-parties accessing detailed game and ticket inventory data. Mary Neubauer has worked for over two years on this issue.

The second relates to the Lottery's relationship with state and local law enforcement officials and/or prosecutors by giving the Lottery's security investigators the necessary flexibility to work with the most appropriate agency when there are suspected violations of Iowa Code 99G related to lottery retailers or products. Thank you to Steve Waymire and his team for being trusted partners of law enforcement in bringing lottery perpetrators to justice.

The other update relates to positioning the lowa Lottery for the future. The lottery's current scratch ticket printing contracts are set to expire at the end of the calendar year. As such, the lottery has been working with the Department of Revenue and the Department of Management to prepare a request for proposals to provide lottery scratch tickets and related services for the future. This public, competitive bidding process is now underway. Jon Roth is to be commended for his work over the last two years to educate others involved in this process.

Strawn concluded his remarks by thanking the entire Iowa Lottery team.

#### **QUARTERLY REPORTS**

#### Revenue (Sales and Marketing):

Roth gave a Revenue report. Fiscal year 2025 sales continue to be lower due to lower jackpots for Powerball and Mega Millions. Through February, revenues are just shy of \$292 million, a decrease of 11.9% from FY24.

In the lotto category, thus far in FY25, Powerball sales of \$25.3 million have experienced a decrease of 53.9% vs. FY24, and Mega Millions with sales of \$21.5 million has experienced a 21.3% decrease vs. FY24. As noted in previous Commission meetings, with the lower cost margin on these games, the decreases in sales this fiscal year also have a significant impact in decreasing proceeds.

In the scratch ticket category, sales have experienced a decrease of 4.3% through the end of February for FY25. However, as noted in December, we are seeing continued improvement.

As noted during the December Commission meeting, with sales facing challenges on all fronts, the Iowa Lottery has been focused on working on offerings and with retailers to positively impact sales:

Holiday Scratch-Tickets: Holiday scratch-tickets are outpacing FY24 by 13.1%.

<u>Self-Serve Kiosks</u>: New state of the art self-kiosks were installed in the market late last year. In February alone, sales through self-serve kiosks increased by 34% over the prior year with a significant portion of that due to the new machines.

<u>InstaPlay</u>: With the implementation of all new InstaPlay games now complete, there are positive sales results in FY25. In September, at the start of the game updates, InstaPlay sales of \$6.1 million were down 7.8% through the end of the month. As of the end of February, sales of \$19.4 million were up by 14.1% fiscal YTD.

<u>Pull-Tabs</u>: Pull-Tab sales continue to be strong with sales of \$10 million; a 21.4% increase through February.

<u>Mega Millions</u>: The lottery has been developing and implementing the components for the launch of the updated Mega Millions game on April 5th.

#### **External Relations:**

Neubauer gave an External Relations report. Each March, the Iowa Lottery participates in Problem Gambling Awareness Month. The 2025 campaign featured two public service announcements featuring a gambling treatment counselor and someone going through gambling addiction treatment. The videos were recorded, edited, and produced in-house by the External Relations team.

The revamp of the Mega Millions game will go live on April 5, 2025. The jackpot in the revamped game will start at \$50 million, there will be bigger prizes at all 9 of the game's prize levels, and the multiplier will be built into all plays. The ticket price will increase to \$5 per play.

#### **Security:**

Waymire gave a Security report. The security team has conducted 55 retailer inspections in the 3rd quarter and 502 inspections YTD.

#### Finance:

French gave a Finance report. Through February, YTD sales are at \$291.9 million. The YTD sales are ahead of budget by \$1.6 million. YTD sales are behind sales for the same period last year by \$39.3 million, largely impacted by the jackpots in Powerball as well as Mega Millions which both exceeded \$1 Billion last year.

Through February, YTD proceeds are at \$60.2 million. The YTD proceeds are more than budgeted by \$9.5 million. YTD proceeds are behind proceeds for the same period last year by \$13.7 million, again largely impacted by the \$1 Billion jackpot runs in Powerball last July and October and Mega Millions last August.

Through February, YTD prize expense is at \$188.3 million. The YTD prize expense is ahead of budget by \$17.7 million. YTD prize expense is behind prizes for the same period last year by \$22.8 million.

YTD operating expenses through February remain under budget at \$928K.

#### **EASY PLAY PRESENTATION:**

Neubauer provided details about the March 12<sup>th</sup> debut of lottery-ticket sales in the checkout lane at Fareway Stores. The new innovative Easy Play option allows quick-pick tickets in Powerball and Mega Millions to be printed from the cash register at checkout. Fareway customers can buy the tickets at any checkout lane staffed by a cashier. Prior to this, lottery tickets could only be purchased at a lottery terminal or self-service kiosk in a retail location.

#### **GAME RULES UPDATES DUE TO ADMINISTRATIVE RULES REVISIONS:**

Roth requested the Commission approve game rules updates to several games in accordance with the administrative rules revisions approved at the December Commission meeting. The game rules updates are for Powerball, Mega Millions, Lotto America, Lucky for Life, Pick 3, and Pick 4.

Cook moved to approve the game rules updates for Powerball, Mega Millions, Lotto America, Lucky for Life, Pick 3, and Pick 4. New seconded. Motion carried unanimously.

#### **NEXT COMMISSION MEETING:**

Wingert stated that the next Commission meeting is scheduled for Tuesday, June 24, 2025 at 10:30 am at the Lottery's office in Clive.

#### **ADJOURNMENT**

Cook moved to adjourn. Rathje seconded. Motion carried unanimously.

TO: Iowa Lottery Commission

FROM: Iowa Department of Revenue Legal Services

This memorandum provides a draft, timeline, and request to proceed to file a rulemaking dedicated to Modernization Rollout 5.

#### **BACKGROUND**

Because the Lottery Commission is charged by statute to "[a]dopt policies and procedures and promulgate administrative rules pursuant to chapter 17A relating to the management and operation of the Iowa lottery," and because the Department has many agency procedure rules related to management of the lottery, the Lottery Commission must review any agency procedure rules that include alcohol and lottery to the extent those rules are now also related to lottery management.

The Department is undergoing its final year of Modernization Rollout 5 to include lottery and alcohol matters into its IMPACT and GovConnectIowa systems. One of the modernization initiatives includes adding lottery and alcohol appeal filings and rule changes are necessary in order to ensure the public is aware. The rulemaking draft itself is provided below, in addition to a timeline that is subject to change. The draft changes include strikethroughs and underlines to indicate what is proposed to be removed or added. It is ideal to try and get the effective date of the amended rules as close to the Rollout Go-Live date as possible, which at this time is scheduled for November 12, 2025.

ITEM 1. Amend rule 701–6.4(99G,123,17A) as follows:

#### 701—6.4(99G,123,17A) Requests for a contested case proceeding.

- **6.4(1)** Any person claiming an entitlement to a contested case proceeding shall file a written request within the time specified by the particular rules or statutes governing the subject matter or, in the absence of such law, the time specified in the agency action in question.
- **6.4(2)** The request for a contested case proceeding should state the name and address of the requester, identify the specific agency action that is disputed and, where the requester is represented by a lawyer, identify the provisions of law or precedent requiring or authorizing the holding of a contested case proceeding in the particular circumstances involved, and include a short and plain statement of the issues of material fact in dispute.
- 6.4(3) A person may submit their request for a contested case proceeding using one of the methods described in Iowa Administrative Code subrule 701–7.3(1).

#### ITEM 2. Amend rule 701–7.3(17A) as follows:

701—7.3(17A,99G,123,421-454)How to submit an appeal, petition or related documents; service. Appeals, petitions, and other documents governed by this chapter may be filed electronically, by mail, or in person, in accordance with the limits described below. Petitions for declaratory order, petitions for rulemaking, and petitions for rule waiver, for all tax types as well as for lottery and alcohol matters but is only available for filing appeals for the following tax types: sales, use, E911, withholding, motor vehicle fee for new registration, vehicle lease, cigarette, tobacco products, alternative nicotine, vapor device, vapor products, drug stamp, utility replacement, central assessments, statewide property, motor fuel, hotel/motel, local option sales, automobile rental, water service excise, individual income, fiduciary income, corporation income, S corporation income, partnership income, composite, franchise, inheritance, moneys and credits, and tax credits and distributions associated with these tax types.
