#### **JURASSIC WORLD Second Chance Promotion Rules**

The JURASSIC WORLD Second Chance promotion (Promotion) is an Iowa Lottery web-based Play It Again® promotion offering ten cash prizes of \$10,000 and two trips to Hawaii. While there, the trip winners will participate in the \$1,000,000 JACKPOT CHALLENGE Event for a chance to win up to \$1,000,000!

The Promotion, which can be entered by members of the Iowa Lottery VIP Club with eligible \$10 JURASSIC PARK Progressive InstaPlay tickets (Game #171) and \$10 JURASSIC WORLD scratch tickets, (Game #743), begins at 10:00 a.m. Central Time (CT) on Tuesday, June 3, 2025, and ends at 9:59 a.m. CT on Wednesday, October 1, 2025. There are two entry deadlines for the prize packages and two draw dates in the promotion. The drawings will be held on August 14, 2025 and October 2, 2025.

The JURASSIC WORLD Second Chance promotion prizes are subject to lottery rules, validation procedures, set-offs and other deductions authorized by law. The Hawaii Trip and \$1,000,000 JACKPOT CHALLENGE Event prize package includes the required state and federal income tax withholding paid on the value of the prize package. There is no all-cash option for the Hawaii Trip and \$1,000,000 JACKPOT CHALLENGE Event prize package. The winners are responsible for all other taxes that may be due and owing.

#### Entry

To enter, an individual must be a current member of or join the lowa Lottery VIP Club. Entrants must legally acquire and submit a nonwinning \$10 JURASSIC PARK Progressive (Game #171) InstaPlay ticket or \$10 JURASSIC WORLD (Game #743) scratch ticket. Individuals enter the promotion as follows: During the eligibility period, entrants log into their VIP Club account on the lowa Lottery website, ialottery.com, to enter the promotion. On the lowa Lottery website, entrants will manually enter the scratch ticket numbers (located on the front of the ticket in the scratch-off area and the back of the ticket).

Entrants can also scan and enter the eligible JURASSIC PARK Progressive InstaPlay tickets or JURASSIC WORLD scratch tickets with the Iowa Lottery LotteryPlus mobile app.

Each nonwinning \$10 JURASSIC PARK Progressive InstaPlay or \$10 JURASSIC WORLD scratch ticket entered will receive one entry in the prize category of the player's choice for either the \$10,000 cash prize or the Hawaii Trip and \$1,000,000 JACKPOT CHALLENGE event. Players will choose the prize category at the time they make an entry into the Promotion. Entries will not carry over from one drawing to the next.

Players may enter multiple tickets, but an eligible JURASSIC PARK Progressive InstaPlay or JURASSIC WORLD scratch ticket can be entered only once. All entries are final. Entrants must follow the VIP Club rules. Players must use a street address for their account information – P.O. boxes are not valid for this promotion or the VIP Club. Entry of a JURASSIC PARK Progressive InstaPlay or JURASSIC WORLD scratch ticket into the promotion is sufficient for presentation of a ticket for validations purpose for this promotion.

# **Eligibility**

An eligible entry is any legally acquired nonwinning \$10 JURASSIC PARK Progressive (Game #171) InstaPlay ticket or \$10 JURASSIC WORLD (Game #743) scratch ticket that has not been previously submitted on the lowa Lottery LotteryPlus app or through the lowa Lottery website as an entry into this promotion. All entrants must be 21 years of age or older.

Except as provided under the "lowa Lottery Chief Executive Officer's Discretion" section below, an eligible entry is one in which the entry information is completed and submitted electronically during the posted entry time, as specified on the lowa Lottery website. Players may attempt to enter or submit up to 40 total entries per day in a VIP Club account. Each attempt of ticket submission counts as one entry attempt. The lowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. October 1, 2025.

Players who have signed up for the lowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the lowa Lottery Commission, lowa Department of Revenue employees, and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the lowa Lottery, and their immediate families, as defined by statute, are not eligible.

### **Drawings**

The lowa Lottery drawings for the Promotion will be held on Thursday, August 14, 2025 and Thursday, October 2, 2025. The lowa Lottery drawings will be held in accordance with the schedule posted to the lowa Lottery's website (ialottery.com) and listed in the JURASSIC WORLD Second Chance promotion rules.

The winners' names will be posted on the lowa Lottery's website by the end of the day following the draw day or as soon as practicable following the determination of the winners. The winners will be sent an email to their VIP Club member email address. Entrants are not required to personally attend the drawings or be present at the time of the drawings to win. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced and awarded.

In order to claim their prize, winners must complete and sign an lowa Lottery Winner Claim Form, along with appropriate tax documentation, and present those documents with a legible copy of their government-issued photo identification to the lowa Lottery by the claim deadline. The winners may present the completed documents at any lowa Lottery regional office open Monday through Friday from 8:00 a.m. to 4:00 p.m., through the lowa Lottery's digital promotion prize claim process, or by mail to the lowa Lottery headquarters office at 13001 University Avenue, Clive, IA 50325. lowa Lottery offices are closed on weekends and state holidays.

The claim deadlines for the Promotion prizes are by 4:00 p.m. on the following dates: August 28, 2025, for the August 14, 2025 drawing winners and October 16, 2025, for the October 2, 2025 drawing winners.

If a valid winner of a \$10,000 cash prize does not present a fully executed lowa Lottery Winner Claim Form and the appropriate documents to the lowa Lottery by the claim deadline, the cash prize will go back into the unclaimed prize pool. If the valid winner of the Hawaii Trip and \$1,000,000 JACKPOT CHALLENGE Event prize package does not present a fully executed lowa Lottery Winner Claim Form and the appropriate documents to the lowa Lottery by the claim deadline, the prize will be awarded to the next valid entrant in the order drawn. If an alternate is required for the Hawaii Trip and \$1,000,000 JACKPOT CHALLENGE Event prize package, an email notification will be sent to the alternate's VIP Club email address and their name will be posted on the lowa Lottery website and mobile app. If an alternate is required for the Hawaii Trip and \$1,000,000 JACKPOT CHALLENGE Event, they must present a fully executed lowa Lottery Winner Claim Form and required documents to the lowa Lottery by 4:00 p.m. on the deadline date listed in the notification email.

By submitting an entry into the Promotion and claiming the prize, the entrant certifies they are the owner of the entry, the entrant is at least 21 years old, the ticket was not stolen or acquired illegally, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the lowa Lottery, the lowa Department of Revenue, and the State of lowa, its elected officials, apprentices, employees, agents, and volunteers. In consideration for participating in the promotion, the entrant waives any and all claims the entrant may have or ever claim to have against the lowa Lottery, the lowa Department of Revenue, and the State of lowa, its employees, agents, or commission members, relating in any way to the promotion. The player also consents to the use by the lowa Lottery and the lowa Department of Revenue of their name or likeness for advertising, trade or promotional purposes without further compensation.

By accepting a Promotion prize, the winner and their heirs, legal representatives, and assigns agree to indemnify, defend, release, and discharge the lowa Lottery, the lowa Department of Revenue, and the State of lowa, and each of their employees, officers, and directors from and against any loss, claim damage, suit, or injury arising out of or relating to the promotion or any action taken pursuant to these rules. The lowa Lottery, lowa Department of Revenue, and the State of lowa are not responsible or liable, in any way, for any personal injuries, illness, death, property damage, or other damages or expense resulting from or arising out of acceptance, fulfillment, use, or misuse of the promotion prize or any element thereof.

Universal Studios Licensing LLC ("Universal") and Amblin Entertainment, Inc. ("Amblin"), each of their parents and/or any of their subsidiaries, affiliates or licensors (Universal, Amblin and each of their parents, subsidiaries, affiliates, and licensors are collectively referred to hereinafter as, the "Universal Entities") and are not sponsors or administrators of the CHALLENGE.

The Iowa Lottery's Hawaii Trip and \$1,000,000 JACKPOT CHALLENGE Event winners will participate in the \$1,000,000 JACKPOT CHALLENGE Event with other participating lottery's winners from across the country for a chance to win up to \$1,000,000. This event will take place during the Hawaii trip.

- The \$1,000,000 JACKPOT CHALLENGE (the "CHALLENGE" or "EVENT") will be conducted according to event and security procedures generated by Scientific Games, LLC ("SG" or "Lottery Vendor") and its third-party underwriters. Prize winners will be mailed the final official event details ("the "Event Details") explaining how the CHALLENGE will be conducted prior to their trip departure.
- Each Prizewinner (or assigned proxy) shall participate as a contestant (the "Contestant") in the CHALLENGE together with Prizewinners from other participating lottery jurisdictions.
- o Prizewinners' guests may sit with Prizewinners in the audience but will not be eligible to be a Contestant in the CHALLENGE unless they have been designated as the Prizewinner's proxy.
- Each Contestant will have one (1) chance to play a series of mini games for the chance to win cash prizes (collectively, the "Challenge Prize"). The total potential Challenge Prize that may be won by each Contestant, shall be based upon the round (defined below) in which the Contestant is participating, and will range from one thousand dollars (\$1,000) up to a chance to win one million dollars (\$1,000,000) ("Grand Prize"). The total Challenge Prize won, less tax withholdings, in the CHALLENGE by the Prizewinner will be mailed to the Prizewinner within thirty (30) business days after the official conclusion of the EVENT, but no later than December 31, 2026.
- The CHALLENGE will consist of four (4) rounds (each a "Round" or plural "Rounds"). Each Round will be played separately.
  - Round 1: Cash Prizes range from seventy-five dollars (\$75) up to one thousand dollars (\$1,000).
  - Round 2: Cash Prizes range from one hundred dollars (\$100) up to five thousand dollars (\$5,000).
  - Round 3: Cash Prizes range from five hundred dollars (\$500) up to fifty thousand dollars (\$50,000).
  - Round 4: Cash Prizes range from three hundred twenty-five dollars (\$325) up to one million dollars (\$1,000,000).
- o SG reserves the right to modify game play provided such change does not results in a lower expected payout for the Contestant for the modified portion.

The odds of winning a Promotion prize will vary depending on the number of entries.

## **Iowa Lottery Chief Executive Officer's Discretion**

If the lowa Lottery Chief Executive Officer (CEO), or the CEO's designee, determines that an otherwise valid entry has been foiled by the intervention of an lowa Lottery employee, lowa Lottery retailer, or lowa Lottery vendor processing error, the CEO may authorize the replacement of an eligible entry. This shall be the player's only recourse against the lowa Lottery or its personnel.

# **Force Majeure**

If the lowa Lottery is hindered from providing the prizes due to riots, acts of God, shortages of labor or materials, war, acts of terrorism, governmental laws, regulations, or restrictions or any other causes of any kind whatsoever which are beyond the reasonable control of the lowa Lottery, then the lowa Lottery, the lowa Department of Revenue, and the State of lowa shall not be liable or responsible for its inability to provide some or all of the prizes discussed herein.

## **Choice of Law and Forum**

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court for the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Iowa Lottery, the Iowa Department of Revenue, or the State of Iowa.

#### **Technical Disclaimer**

The lowa Lottery, the lowa Department of Revenue, and the State of lowa are not responsible for and shall not be liable for:

- Any damage to an entrant's computer system or device that is directly or indirectly caused by accessing or downloading content from https://www.ialottery.com or otherwise participating in this promotion; or
- Any computer system, phone line, hardware, software, cell phone, application, or program malfunctions; or
- Other errors, failures, dropped or delayed computer transmissions or network connections that are human or technical in nature.

Without limiting the generality of the foregoing, the lowa Lottery, the lowa Department of Revenue, and the State of lowa are not responsible for incomplete, illegible, misdirected, late, lost, damaged, or stolen entries; lost, interrupted, inaccessible, or unavailable networks, satellites, Internet Service Providers (ISPs), websites, or other connections; miscommunications; failed, jumbled, scrambled, delayed, or misdirected computer, telephone, or cable transmissions; or any technical malfunctions, failures, or difficulties; printing errors; clerical, typographical, or other errors in the offering or announcement of any prize or in any prize notification documents; the incorrect or inaccurate capture of information or the failure to capture information; or other errors of any kind or nature.

Caution: Any attempt to deliberately damage any website related to the lowa Lottery, the lowa Department of Revenue, and the State of lowa or to undermine the legitimate operation of the promotion may be in violation of criminal and civil laws and will result in disqualification if the individual is an entrant. If such an attempt is made, the lowa Lottery, the lowa Department of Revenue, and the State of lowa reserve the right to seek remedies and damages from any such person to the fullest extent of the law, including criminal prosecution. The lowa Lottery, the lowa Department of Revenue, and the State of lowa, in each entity's sole discretion, reserve the right to cancel the promotion if the system through which the promotion is operated has become technically corrupted or if the integrity of the promotion has in any way been compromised.
