MINUTES IOWA LOTTERY BOARD

December 14, 2023 10:30 a.m.

The Iowa Lottery Board convened at 10:30 a.m. at Lottery Headquarters in Clive; Board Chairperson Katie New presiding.

CALL TO ORDER

New called the meeting to order at 10:30 a.m. and roll was taken. There was a quorum. New announced the meeting would be held via teleconference in accordance with lowa Code section 21.8.

Wingert moved to conduct the meeting via teleconference. Cook seconded. Motion carried unanimously.

APPROVAL OF AGENDA

Wingert moved to approve the agenda for the meeting. Rathje seconded. Motion carried unanimously.

APPROVAL OF MINUTES

Cook moved to approve the September 26, 2023 Board meeting minutes. Wingert seconded. Motion carried unanimously.

CEO REPORT

Strawn shared a heartfelt message received from a Lottery player who recently won a concert prize in a Play It Again promotion.

Strawn stated sales through November are \$214,532,943; which represents a 5.14% year-over-year increase in sales. Proceeds through November are \$49,416,943; which represents a 3.1% year-over-year increase in proceeds. Sales commissions paid to retailers through November are up 5.7% year-over-year.

Strawn discussed operational integrity as it relates to the public misreporting of the November 27 Powerball winning numbers. The Lottery team operated with transparency and integrity in identifying, fixing, and publicly communicating the mistake. Strawn indicated he ordered an independent third-party review of the Iowa Lottery and Scientific Games procedures in order to prevent the type of human error that occurred on November 27 from happening again in the future.

Strawn ended his report by thanking the Board for their continued support and oversight.

QUARTERLY REPORTS

Revenue (Sales and Marketing):

Roth gave a Revenue report. Through November, sales have continued at a strong pace with \$214.5 million in sales. That was a 5.1% increase versus FY23, and exceeded the five year average by 25.5%.

Scratch Ticket Category - YTD, sales have been strong for Scratch tickets with \$124.5 million in sales, or a 5.1% increase vs. prior year. The sales performance through November is important as we have a different strategy this year with significantly less holiday tickets introduced into the market, leading to significantly less short term change over for our retailers, more focus on sales promotions by our sales team, and ultimately lower development costs.

Lotto Category - We have experienced strong performance from the Lotto category with essentially flat performance compared to record setting FY23, and particularly from Powerball with a 3.0% increase over last year and 0.5% year over year increase for Mega Millions. Lucky for Life also performed well with a 3.3% increase. The outlier here is Lotto America with sales of \$3.1 million, or a 33.5% decrease versus its own jackpot run last year. Compared to FY20 through FY22 though, Lotto America performance remains strong with over 20% increases compared to those years.

InstaPlay Category - We experienced some downturn in InstaPlay performance with the larger jackpot runs for Powerball and Mega Millions. While not as strong in terms of performance as Scratch tickets, the 0.7% increase over FY23 is still contributing to increased sales this year. We have a new InstaPlay Monopoly game launching in March which should further improve sales this fiscal year.

Pull-Tab Category - Sales are down YTD by 2.2% versus last year. Going forward, we're working on including a strategic review of the Pull-Tab category into a one of the Lottery's larger initiatives for a request for proposal for scratch tickets development and vendor loyalty program.

External Relations:

Neubauer gave an External Relations report. During December, the Lottery is reminding consumers about responsible gifting. The messaging is part of the national campaign by the National Council on Problem Gambling and NASPL. Throughout December, you'll see this message online, on outdoor billboards, in retail locations, on social media, and on the radio during Winning Minute spots.

The Lottery's contract with Scientific Games for the statewide central gaming system includes a research budget. This year, the research dollars are dedicated to the issue of responsible gambling. Surveys are currently being deployed to ask people about the types of gambling in which they participate. The survey

will also identify people's understanding, or misunderstanding, of gambling concepts. The research results will be used to tweak responsible play messaging to reach consumers in new ways.

Neubauer concluded her report by stating that the Lottery currently has two unclaimed prizes of \$2 million each, both in the Powerball game.

Security:

Waymire's Security report was provided in the board packet.

Finance:

Podrebarac gave a financial report. Through November, YTD sales are \$214.5 million. The YTD sales are ahead of budget by \$57.8 million, or 36.8%. YTD sales are also ahead of sales for FY23 by \$10.5 million, or 5.1%.

Through November, YTD proceeds are \$49.4 million. The YTD proceeds are ahead of budget by \$19.2 million, or 63.5%. YTD proceeds are also ahead of proceeds for FY23 by \$1.5 million, or 3.1%. The YTD sales and proceeds were impacted by high jackpots in Powerball and Mega Millions in FY23 and FY24 Additionally, we launched a new Powerball add-on feature, *Powerball Double Play*, at the beginning of November 2023.

Through November, YTD prize expense is \$135.6 million. The YTD prize expense is ahead of budget by \$38.2 million, or 39.2%. YTD prize expense is also ahead of prizes for FY23 by \$8.7 million, or 6.9%.

YTD operating expenses through November remain under budget at \$5.6 million and are comparable to the 5-year average.

SUMMER & FALL PROMOTIONS REVIEW

Roth provided an overview of several promotions; including the success of 3 recently completed promotions; including Kickoff to Kinnick, Cyclone Football, and Powerball's First Millionaire. Roth shared information about current promotions including Countdown to Carver and Million Dollar Holiday. He also previewed upcoming promotions including Bonus Basketball; Monopoly; and country concert experiences.

POWERBALL DRAW UPDATE

Roth shared information regarding the complication with the Powerball drawing that took place on November 27, 2023. With the launch of the new Powerball Double Play, Powerball now has two distinct and separate drawings. As part of the drawing process, the winning numbers from these two distinct drawings are input into the Lottery's central gaming system. On November 27th, there was a human error caused by Lottery staff as well as by the staff of the central gaming system vendor, Scientific Games, with the result that first 5 numbers input into the central gaming system for the Powerball drawing were incorrect with both draw staff independently inputting the same incorrect numbers. The Powerball Double Play numbers were entered and posted correctly.

Draw staff at all lotteries utilize the same reporting information provided by the Multi-State Lottery Association (MUSL) for winning numbers in Powerball and the same method of data entry is also used across lottery jurisdictions. Additionally, having these numbers input independently by the Lottery and by Scientific Games staff is a MUSL rule for participation geared to protect the integrity of the game.

The result of this error is that incorrect numbers for Powerball were in the Lottery's central gaming system and posted on the Lottery's website from 12:30am to 7:07am on Tuesday morning, November 28th. At 7:07am, the incorrect Powerball numbers were removed from the central gaming system and the Lottery's website. Scientific Games then reconstructed the game purchase and draw data, with the result that the correct numbers were loaded into the central gaming system and posted on the lottery's website and mobile app at 3:28pm.

During the time that incorrect numbers were posted on the website, there were a total of six tickets with incorrect Powerball numbers that were paid a prize. The total amount paid for these incorrect tickets paid was \$69. The lowa Lottery released social media messages on Tuesday, November 28th and more messages along with a press release on Wednesday, November 29th asking that anyone believing they had a correct winning ticket scanned during the early morning of Tuesday, November 28th to contact the Lottery for assistance. Furthermore, there were two tickets with the correct winning Powerball numbers that were unable to claim their prize the morning of November 28th. One of these tickets has been claimed for a prize of \$200.

Following the drawing error, the Lottery and Scientific Games took immediate actions to review processes. Additional verification steps were added by both the Lottery and by Scientific Games to ensure enhanced safeguards going forward. Matt Strawn has directed the Lottery and Scientific Games to undergo a joint, independent 3rd party review of their respective draw processes, including potential recommendations for improvements for both organizations.

By proactively providing timely information about the reporting error in the drawing, our efforts were focused on alerting the public and players to the situation. Integrity is at the heart of the lowa Lottery's operations. And while we celebrate big winners and sales results, it is also just as important to be transparent for those times when things do not go as well.

ADJOURNMENT

Wingert moved to adjourn. Cook seconded. Motion carried unanimously.

Extension to the Agreement for Creative Advertising Services between the Iowa Department of Revenue and Strategic America executed July 1, 2018

This Extension ("Extension") to the Agreement stated above ("Agreement") by and between the Iowa Department of Revenue ("IDR"), an executive branch agency of the State of Iowa into which Iowa Lottery Authority has been incorporated as of July 1, 2023, and Strategic America ("Agency"), is effective on July 1, 2024.

Section 1: Extension

On July 18, 2018 the parties entered into the Agreement for a two-year term with four one-year option periods. IDR exercised its fourth option to extend the Agreement's term through June 30, 2024. Pursuant to Iowa Administrative Code rule 11-118.16(2), IDR submitted a waiver request to the Iowa Department of Administrative Services ("DAS") to waive the requirements of Iowa Administrative Code rule 11-118.11(3) regarding the maximum duration of service contracts. DAS subsequently approved IDR's waiver request to extend the Agreement through June 30, 2025. The Agency shall submit an updated Schedule B to reflect contractually agreed rates which, when approved by IDR, will be incorporated into this Agreement as if fully set forth herein.

Section 2: Successors and Assigns.

This Extension shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.

Section 3: Entire Agreement.

This Agreement and the Extension (including any written amendments thereto), collectively, is the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.

Section 4: Ratification & Authorization.

Except as expressly amended and supplemented herein, the Extension shall remain in full force and effect, and the parties hereby ratify and confirm the terms and conditions thereof. Each party to this Extension represents and warrants to the other that it has the right, power, and authority to enter into and perform its obligations under this Extension, and it has taken all requisite actions (corporate, statutory, or otherwise) to approve execution, delivery, and performance of this Extension, and that this Extension constitutes a legal, valid, and binding obligation.

Section 5: Execution.

IN WITNESS WHEREOF, in consideration of the mutual covenants set forth above and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties have entered into the above Extension and have caused their duly authorized representatives to execute this Extension.

Revised Retail Compensation Program Re:

With the introduction of Powerball Double Play, there is the need to update the Lottery's Retail Compensation Program to include a retail bonus payout amount for the top \$10 million Powerball Double Play prize. Attached is the updated Retailer Compensation Program which now includes the retailer payout of \$5,000 for selling the winning \$10 million Powerball Double Play ticket. No other retail bonus payouts have been changed.

In addition to the bonus payment addition for Powerball Double Play, language in the Ticket Allowance section has also been updated to define tickets as "damaged or produced by mistake" for both On-Line Games and InstaPlay Games. No other changes were made in the Ticket Allowance section.

IOWA LOTTERY

Retailer Compensation Program April 2024

ON-LINE GAMES

Retailers will receive a base commission rate of 5.5% on all on-line tickets sold.

Ticket Allowance:

Retailers will receive an additional 0.1% of the sales of all on-line games added to the base commission rate for tickets that are damaged or produced by mistake in error.

High Tier Prize Sales Bonus:

Powerball Jackpot winning ticket	\$10,0	000
Mega Millions Jackpot winning ticket	\$10,0	000
Powerball Double Play \$10 million winning ticket	\$ 5,0	000
Lotto America Jackpot winning ticket	\$ 5,0	000

With the exception of the prizes listed above, all non-jackpot winning on-line game tickets of \$100,000 or more will receive a bonus of 1/10 of 1 percent of the prize amount (e.g. \$100,000 winning ticket earns a \$100 bonus).

Peak Sales Bonuses on Powerball/Powerplay/Double Play and Mega Millions/Megaplier:

Retailers will receive a 0.75% sales bonus on all sales when the Powerball or Mega Millions jackpot is equal to or exceeds \$400 million. Sales will be tracked during the jackpot run and the bonuses will be awarded after the jackpot is won.

INSTAPLAY GAMES

Retailers will receive a base commission rate of 5.5% on all InstaPlay tickets sold.

Ticket Allowance:

Retailers will receive an additional 0.1% of the sales of all InstaPlay games added to the base commission rate for tickets that are damaged or produced by mistake in error.

INSTANT-SCRATCH GAMES

Retailers will receive 5.5% commission on the sale of all instant tickets.

Retailers can become GOLD STAR PROGRAM members and will receive a 7% commission on the sale price of tickets sold when they meet the following requirements:

1. Comply with all advertising requirements:

- a. Lottery Door Decal
- b. Game Brochures

^{*} Lucky for Life Top Prize is \$1,000 a day for life

^{**}Lucky for Life Second Prize is \$25,000 a year for life

- c. 19" Flat Panel Monitor (The monitor must be located in the primary sales area adjacent to the Wave terminal.)
- 2. Sell sixteen (16) or more different games from dispenser(s). Games must be:
 - a. Displayed in the primary sales area in a highly visible Lottery approved location
 - b. Displayed on the front counter in plain view of the public, in Lottery approved dispensers
 - c. Maintain inventory levels necessary to keep the dispensers full at all times
- 3. As a function of the courier delivery system, the retailer agrees to accept the delivery of, activate and place the tickets for sale.
- 4. Employees will not purchase or play lottery tickets while on duty.

Gold Star retailers must be in compliance with the above requirements. If the retailer is not in compliance when the DSR makes the (scheduled) sales call, the DSR must change the retailer back to the 5.5 % commission rate. If the retailer meets the requirements, they will remain at the 7% Gold Star commission rate.

PULL-TAB GAMES

Retailers will receive a 5% commission on the sale of all pull-tab tickets.

OTHER INCENTIVES

Through the course of a fiscal year, the Lottery may choose to offer special incentives for retailer related activities not covered by the categories detailed elsewhere in this document. The incentives would include, but are not limited to, incentive money, lottery tickets and merchandise prizes. The total value of the incentives for this section will not exceed \$40,000 in any fiscal year.
