

will be eligible for the July 6 drawing for the Knoxville Nationals prize package. Players may enter multiple tickets, but an eligible Powerball ticket can be entered only once. All entries are final. Entrants must follow the VIP Club rules. Players must use a street address for their account information – P.O. boxes are not valid for this promotion or the VIP Club. Entry of a Powerball ticket into the promotion is sufficient for presentation of a ticket for validation purposes for this promotion. Players will need to keep their Powerball ticket to claim any prize won in a multi-state Powerball drawing held on Monday, Wednesday and Saturday evenings. While a VIP Club member can enter multiple tickets, each person can win only prize per race day. A player could win a prize package for each drawing they enter.

Eligibility

An eligible entry is any legally acquired Iowa Powerball ticket purchased May 1, 2023 through 9:59 a.m. July 5, 2023 that has not been previously submitted as an entry into this promotion on the Lottery website or the Iowa Lottery LotteryPlus app. Winning and nonwinning Iowa Powerball tickets are eligible for entry in the promotion.

Except as provided under the “CEO’s Discretion” herein below, an eligible entry is one in which the entry information is completed and submitted electronically during the posted entry time as specified on the Iowa Lottery website. Players may attempt to enter or submit up to 40 total entries per day in a VIP Club account. Each attempt of ticket submission counts as one entry attempt. The Iowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. July 5, 2023.

All entrants must be 21 years of age or older. Players who have signed up for the Iowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the Iowa Lottery Board of Directors and Iowa Lottery employees and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the Lottery, and their immediate families, as defined by statute, are not eligible.

Drawings

The Lottery will hold three category drawings, two on May 24 and one on July 6, 2023. On May 24 the Lottery will draw for 10 winners of a June 9 World of Outlaws prize package and 10 winners of a June 10 World of Outlaws prize package. On July 6, the Lottery will draw for 20 winners of a Knoxville Nationals prize package and a semifinalist entry for the NASCAR Powerball Playoff Drawing on Aug. 12. The drawings will be held in accordance with the schedule posted to the Lottery’s website (ialottery.com) and listed in the rules. The Race Into Summer promotion drawings will be held under the supervision of an independent auditor. All drawings of the Iowa Lottery are public events and the Lottery will comply with any public health directives in effect at the time of these drawings. Persons interested in observing drawings are invited to receive detailed information by contacting the Iowa Lottery Security Division in Des Moines at 515/725-7900; TTY Relay Iowa at 800/735-2942; or by email directed to WMaster@ialottery.com. A request to observe a drawing must be received by the Lottery no later than seven days in advance of the drawing. All drawings are recorded.

The winners’ names will be posted on the Lottery’s website and mobile app by the end of the day following the draw day or as soon as available. Each selected winner will be sent an email to their VIP Club member email address. Entrants are not required to personally attend the drawing or be present at the time of the drawing to be determined a winner. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced.

The prize winners in the Race Into Summer promotion drawings must complete and sign a winner claim form along with appropriate tax documentation and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery by the claim deadline. The winners of the World of Outlaws prize packages must present their claim documents to the Iowa Lottery by 4:00 p.m. June 5, 2023. The winners of the Knoxville Nationals prize package must present their claim documents by 4:00 p.m. July 20, 2023. to receive their prize. The winners of a Race Into Summer promotion prize must present the completed documents at any Iowa Lottery regional office open Monday through Friday from 8:00 a.m. to 4:00 p.m., by the Iowa Lottery’s digital promotion prize claim process, or by mail to the Iowa Lottery headquarters office at 13001 University Avenue, Clive, IA 50325. Lottery offices are closed on state holidays. If a valid winner of a Race Into Summer promotion prize does not present a fully executed claim form and the appropriate documents to the Lottery by the claim deadline, the prize package will be awarded to the first eligible alternate in the order they were drawn. If an alternate(s) is required for the prize package, an email notification will be sent to the alternate’s VIP Club email address and their name will be posted on the Lottery website. If an alternate(s) is required for the World of Outlaws prize package, they must present a fully executed winner claim form and required documents to the Iowa Lottery by 4:00 p.m. June 8, 2023. If an alternate(s) is required for the Knoxville Nationals prize package, they must present a fully executed claim form and required documents to the Iowa Lottery by 4:00 p.m. Aug. 3, 2023.

By submitting an entry into the Race Into Summer promotion and claiming the prize, the entrant certifies they are the owner of the entry, the entrant is at least 21 years old, the ticket is not stolen, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the State of Iowa and the Iowa Lottery, its elected officials, apprentices, employees, agents and volunteers. In consideration for participating in the promotion, the entrant waives any and all claims the entrant may have or ever claim to have against the Iowa Lottery, its employees, agents, or board members, relating in any way to the promotion. The player also consents to the use by the Lottery of their name and/or likeness for advertising, trade or promotional purposes without further compensation.

By accepting a Race Into Summer promotion prize, the winner and their heirs, legal representatives, and assigns agree to indemnify, defend, release, and discharge the Iowa Lottery, State of Iowa, and its employees, officers and directors from and against any loss, claim damage, suit or injury arising out of or relating to the promotion or any action taken pursuant to these rules.

The Multi-State Lottery Association will conduct the NASCAR Powerball Playoff series of elimination drawings for the cash prizes of up to the \$1 million prize. The drawing for the \$1 million will be broadcast live from the NASCAR Cup Series Championship Race at Phoenix Raceway in Arizona on Nov. 5, 2023. There are 29 participating lotteries in the NASCAR Powerball Playoff promotion.

NASCAR Powerball Playoff drawings and prizes:

- Draw Date: Aug. 12 -- Announced Aug. 26 at Daytona Beach, FL (Coke Zero Sugar 400 at Daytona International Speedway), 16 semifinalists selected from among the qualifying entries of all participating lotteries;
- Draw Date: Sept. 9 – Announced Sept. 16 at Bristol, TN (Bass Pro Shops Night Race at Bristol Motor Speedway), 12 semifinalists advance from 16, 4 eliminated win \$2,500;
- Draw Date: Oct. 1 – Announced Oct. 8 at Concord, NC (Bank of America Roval 400 at Charlotte Motor Speedway), 8 semifinalists advance, 4 eliminated win \$5,000;
- Draw Date: Oct. 11 – Announced Oct. 29 at Martinsville, VA (Xfinity 500 at Martinsville Speedway), 4 finalists advance and win the VIP Trip to Phoenix; 4 eliminated win \$7,500;
- Draw Date: Nov. 5 – Announced at Avondale, AZ (NASCAR Cup Series Championship Race at Phoenix Raceway), 1 winner of \$1 million and 3 winners of \$10,000.

Odds
