

Suite Seats Promotion Rules

The Suite Seats promotion is an Iowa Lottery VIP Club web-based Play It Again® promotion offering a VIP Suite experience with a pair of tickets to a session of the NCAA Men’s College Basketball Tournament in Des Moines, March 16 and 18, or the NBA game in Minneapolis on March 31 between the Los Angeles Lakers and the Minnesota Timberwolves. This promotion, which can be entered by members of the VIP Club with eligible \$10 Money Madness and \$10 Triple Tripler scratch tickets, begins at 10:00 a.m. Central Time (CT) on Wed. Jan. 4, 2023 and its entry period ends at 9:59 a.m. on Tues., Feb. 28, 2023. There will be a total of 58 Suite Seats winners: 48 winners of an NCAA Men’s College Tournament Session VIP Suite experience in Des Moines and 10 winners of an NBA Los Angeles Lakers vs. Minnesota Timberwolves Suite experience in Minneapolis.

*The Suite Seats promotion prizes are subject to lottery rules, validation procedures, off-sets and deductions authorized by law. The Suite Seats prize packages include the required state withholding tax paid on the value of the prize, but the winners are responsible for all other taxes that may be due or owing.

Entry

Entrants must join or be a current member of the Iowa Lottery VIP Club. Entry into the promotion is accomplished by legally acquiring an eligible \$10 Money Madness or \$10 Triple Tripler scratch ticket. If the ticket is a nonwinner, players can log in to their VIP Club account at the Iowa Lottery website, ialottery.com, to enter the Suite Seats promotion with the entry number (located on the front of the ticket) and the ticket number (located on the back of the ticket above the bar code) or scan the ticket to enter with the Iowa Lottery LotteryPlus mobile app. Each nonwinning ticket entered will receive one entry in the category drawing of the member’s choice.

Players may enter multiple tickets, but an eligible scratch ticket can be entered only once. While a VIP Club member can enter multiple times in multiple drawings during the promotion, each person may win only one prize in each category drawing.

Winning scratch tickets are not eligible for entry into this promotion. All entries are final. Entrants must follow the VIP Club rules. Players must use a street address for their account information – P.O. boxes are not valid for this promotion or the VIP Club. Entry of a nonwinning scratch ticket into the promotion is sufficient for presentation of a ticket for validation purposes for this promotion. Players do not need to keep their nonwinning scratch tickets after entering them in the promotion.

Eligibility

An eligible entry is any legally acquired Iowa Lottery Game #635 Money Madness or Game #636 Triple Tripler nonwinning scratch ticket that has not been previously submitted as an entry into this promotion on the Lottery website or the Iowa Lottery LotteryPlus app.

Except as provided under the "CEO's Discretion" herein below, an eligible entry is one in which the entry information is completed and submitted electronically during the posted entry time as specified on the Iowa Lottery website. Players may attempt to enter or submit up to 40 total entries per day in a VIP Club account. Each attempt of ticket submission counts as one entry attempt. The Iowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. February 28, 2023.

All entrants must be 21 years of age or older. A person can only win one VIP Suite Seats prize package per drawing category. A person could win one prize in each of the Suite Seats category drawings that they have entered.

Players who have signed up for the Iowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the Iowa Lottery Board of Directors and Iowa Lottery employees and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the Lottery, and their immediate families, as defined by statute, are not eligible.

Drawings

The four drawings for the Suite Seats promotion will be held on March 1, 2023. The drawings will be held in accordance with the schedule posted to the Lottery's website (ialottery.com) and listed in the rules. The Suite Seats promotion drawings will be held under the supervision of an independent auditor. All drawings of the Iowa Lottery are public events. Persons interested in observing drawings are invited to receive detailed information by contacting the Iowa Lottery Security Division at 515/725-7900; TTY Relay Iowa at 800/735-2942; or by email directed to WMaster@ialottery.com. A request to observe a drawing must be received by the Lottery no later than seven days in advance of the drawing. All drawings are recorded.

The winners' names will be posted on the Lottery's website and mobile app by the end of the day following the draw day or as soon as available. Each selected winner will be sent an email to their VIP Club member email address. Entrants are not required to personally attend the drawing or be present at the time of the drawing to be determined a winner. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced.

The prize winners in the Suite Seats promotion drawings must complete and sign a winner claim form along with appropriate tax documentation and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery by 4 p.m. Wed., March 8, 2023 to claim their prize. The winners of a Suite Seats promotion prize must present the completed documents at any Iowa Lottery regional office open Monday through Friday from 8:00 a.m. to 4:00 p.m., or by utilizing the Iowa Lottery's digital promotion prize claim process. Lottery offices are closed on state holidays. If a valid winner of a Suite Seats prize package does not present a fully executed claim form and the appropriate documents to the Lottery by 4:00 p.m., March 8, 2023, the Suite Seats prize package will be awarded to the first eligible alternate in the order they were drawn. If an alternate(s) is required for the Suite Seats prize package, an email notification will be sent to the alternate's VIP Club email address and their name will be posted on the Lottery website. If an alternate(s) is required for the prize package, they must present a fully executed winner claim form and required documents to the Iowa Lottery by 4:00 p.m. Tues., March 14, 2023.

By submitting an entry into the Suite Seats promotion and claiming the prize, the entrant certifies they are the owner of the entry, the entrant is at least 21 years old, the ticket is not stolen, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the State of Iowa and the Iowa Lottery, its elected officials, apprentices, employees, agents and volunteers. In consideration for participating in the promotion, the entrant waives any and all claims the entrant may have or ever claim to have against the Iowa Lottery, its employees, agents, or board members, relating in any way to the promotion. The player also consents to the use by the Lottery of their name and/or likeness for advertising, trade or promotional purposes without further compensation.

By accepting a Suite Seats promotion prize, the winner and their heirs, legal representatives, and assigns agree to indemnify, defend, release, and discharge the Iowa Lottery, State of Iowa, and its employees, officers and directors from and against any loss, claim damage, suit or injury arising out of or relating to the promotion or any action taken pursuant to these rules.

Odds

The odds of winning a Suite Seats promotion prize will vary depending on the number of entries.

Iowa Lottery CEO's Discretion

If the CEO, or the CEO's designee, determines that an otherwise valid entry has been foiled by the intervention of a Lottery employee, Lottery retailer or Lottery vendor processing error, the CEO may authorize the replacement of an eligible entry. This shall be the player's only recourse against the Lottery or its personnel.

Force Majeure

If the Iowa Lottery is hindered from providing the prizes due to riots, acts of God, shortages of labor or materials, war, acts of terrorism, governmental laws, regulations or restrictions or any other causes of any kind whatsoever which are beyond the reasonable control of the Iowa Lottery, the Lottery shall not be liable or responsible for its inability to provide some or all of the prizes discussed herein.

Choice of Law and Forum

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court for the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Lottery or the State of Iowa.

Technical Disclaimer

The Iowa Lottery is not responsible for and shall not be liable for:

- Any damage to an entrant's computer system or device that is directly or indirectly caused by accessing or downloading content from <https://www.ialottery.com> or otherwise participating in this promotion; or
- Any computer system, phone line, hardware, software, cell phone, application, or program malfunctions; or
- Other errors, failures, dropped or delayed computer transmissions or network connections that are human or technical in nature.

Without limiting the generality of the foregoing, the Iowa Lottery is not responsible for incomplete, illegible, misdirected, late, lost, damaged or stolen entries; or for lost, interrupted, inaccessible or unavailable networks, satellites, Internet Service Providers (ISP), website or other connections; or for miscommunications; failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmission; or for any technical malfunctions, failures or difficulties; printing errors; clerical, typographical or other error in the offering or announcement of any prize or in any prize notification documents, or other errors of any kind or nature; or for the incorrect or inaccurate capture of information or the failure to capture information.
