Cash Prizes are Coming to Town Promotion Rules

The Cash Prizes are Coming to Town promotion is an IA Lottery VIP Club[™] web-based Play It Again[®] promotion offering \$1,100,000 in cash prizes. The promotion, which can be entered by members of the VIP Club with eligible holiday scratch and InstaPlay tickets, begins at 10:00 a.m. Central Time (CT) on Tuesday, October 22, 2024, and its entry period ends at 9:59 a.m. CT on Wednesday, January 8, 2025. There are two entry deadlines for the prize packages involved and two draw dates in the promotion. The drawings will be held on December 10, 2024, and January 9, 2025. There will be 20 winners of \$25,000 cash prizes, 1 winner of a \$100,000 cash prize and 2 winners of \$250,000 cash prizes.

Cash Prizes are Coming to Town Promotion Prize Structure

*All entries that were not selected as a winner of a \$25,000 prize will be eligible for the Grand Prize Drawing. **ELF** tickets selected as a winner of a \$25,000 or \$250,000 prize are not eligible for the **ELF** Second Chance Drawing.

The Cash Prizes are Coming to Town promotion prizes are subject to lottery rules, validation procedures, set-offs and deductions authorized by law. The Iowa Lottery will withhold all state and federal taxes as may be required by law. Winners are responsible for all other taxes that may be due and owing.

Entry

To enter, an individual must be a current member or join the IA Lottery VIP Club. Entrants must legally acquire and submit a nonwinning holiday ticket in one of the eligible games for this promotion. Those are: **ELF** InstaPlay \$5 game (Game #157) Reindeer Riches InstaPlay \$2 game (Game #159) purchased on or after October 6, 2024 or Shiny & Bright \$2 scratch game (Game #720), Tree-Mendous Crossword \$3 scratch game (Game #721), Merry Mint Money \$5 scratch game (Game #722), **ELF** \$5 scratch game (Game #723), Snowfall \$10 scratch game (Game #724), Money Gift \$10 scratch game (Game #725), and Winter Winnings \$20 scratch game (Game #726). During the eligibility period, entrants log in to their VIP Club account on the Iowa Lottery website, ialottery.com, to enter the promotion. Entrants can scan and enter the eligible holiday tickets with the Iowa Lottery LotteryPlus mobile app, or manually enter the number from the front of the InstaPlay ticket or scratch ticket numbers (located on the front of the ticket in the scratch-off area and the back of the ticket) on the Iowa Lottery website at ialottery.com. The promotion will begin at 10:00 a.m. Tuesday, October 22, 2024, and end at 9:59 a.m. Wednesday, January 8, 2025. There will be two entry deadlines in the promotion. Each ticket entered will receive one entry in the drawing. Those tickets entered through 9:59 a.m., Monday, December 9, 2024, will be eligible for the first drawing for 10 prizes of \$25,000 on December 10, 2024. All entries not selected as a winner in the December 10, 2024 drawing, will remain eligible for the Grand Prize Drawing on Thursday, January 9, 2025. The second entry period will begin at 10:00 a.m. Monday, December 9, 2024, and end at 9:59 a.m. Wednesday, January 8, 2025, for the second drawing of 10 prizes of \$25,000, and the Grand Prize drawing. A person can win only one \$25,000 prize on each draw date. All holiday tickets entered during the promotion that were not previously selected as a winner of a \$25,000 prize will be eligible for the Grand Prize drawing on Thursday, January 9, 2025, to win one of two prizes of \$25,000. A person can win only one \$250,000 prize in the Grand Prize Drawing. There will be an exclusive **ELF** Second Chance Drawing for all **ELF** tickets entered during the promotion on Thursday, January 9, 2025 from among **ELF** scratch and InstaPlay tickets entered during the promotion. **ELF** tickets selected as a winner of a \$25,000 prize are not eligible for the **ELF** Second Chance Drawing.

Players may enter multiple holiday tickets, but each eligible ticket can be entered only once. All entries are final. Entrants must follow the VIP Club rules. Players must use a street address for their account information -P.O. boxes are not valid for this promotion or the VIP Club.

Eligibility

An eligible entry is any legally acquired nonwinning holiday scratch or InstaPlay ticket that has not been previously submitted on the Iowa Lottery LotteryPlus app or through the Iowa Lottery website as an entry into this promotion. All entrants must be 21 years of age or older. A person can only win one Cash Prizes are Coming to Town prize per drawing.

Except as provided under the "lowa Lottery Chief Executive Officer's Discretion" section below, an eligible entry is one in which the entry information is completed and submitted electronically during the posted entry time, as specified on the Iowa Lottery website. Players may attempt to enter or submit up to 40 total entries per day in a VIP Club account. Each attempt of ticket submission counts as one entry attempt. The Iowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. January 8, 2025.

Players who have signed up for the lowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the lowa Lottery Commission, lowa Lottery employees, lowa Department of Revenue staff who support the Lottery Division, and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the Lottery, and their immediate families, as defined by statute, are not eligible.

Drawings

The Iowa Lottery drawings for the Cash Prizes are Coming to Town promotion will be held on Tuesday, December 10, 2024 and Thursday, January 9, 2025. The Iowa Lottery drawings will be held in accordance with the schedule posted to the Iowa Lottery's website (ialottery.com) and listed in the Cash Prizes are Coming to Town promotion rules.

The drawings will be held under the supervision of an independent auditor. All drawings of the lowa Lottery are public events and the Lottery will comply with any public health directives in effect at the time of these drawings. Persons interested in observing drawings are invited to receive detailed information by contacting the lowa Lottery Security Division by telephone at (515) 725-7900, by TTY Relay lowa at (800) 735-2942, or by email directed to WMaster@ialottery.com. A request to observe a drawing must be received by the lowa Lottery no later than seven days in advance of the drawing. All drawings are recorded.

The winners' names will be posted on the Lottery's website by the end of the day following the draw day or as soon as practicable following the determination of the winners. Each winner will be sent an email to their VIP Club member email address. Entrants are not required to personally attend the drawing or be present at the time of the drawing to win. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced.

In order to claim their prize, winners must complete and sign an Iowa Lottery Winner Claim Form, along with appropriate tax documentation, and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery within ten business days after the draw date to claim their prize. Winners may present the completed documents at any Iowa Lottery regional office open Monday through Friday from 8:00 a.m. to 4:00 p.m., through the Iowa Lottery's digital promotion prize claim process, or by mail to the Iowa Lottery headquarters office at 13001 University Avenue, Clive,

IA 50325. Lottery offices are closed on weekends and state holidays. If a winner of a Cash Prizes are Coming to Town cash prize does not claim their prize by the claim deadline, the cash prize will go back into the unclaimed prize pool.

By submitting an entry into the Cash Prizes are Coming to Town promotion and claiming the prize, the entrant certifies they are the owner of the entry, the entrant is at least 21 years old, the ticket was not stolen or acquired illegally, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the lowa Lottery, the lowa Department of Revenue, and the State of lowa, its elected officials, apprentices, employees, agents, and volunteers. By accepting a Cash Prizes are Coming to Town promotion prize, the winner and their heirs, legal representatives, and assigns agree to indemnify, defend, release, and discharge the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa, and each of their employees, officers, and directors from and against any loss, claim damage, suit, or injury arising out of or relating to the promotion or any action taken pursuant to these rules. The Iowa Lottery, Iowa Department of Revenue, and the State of Iowa are not responsible or liable, in any way, for any personal injuries, illness, death, property damage, or other damages or expense resulting from or arising out of acceptance, fulfillment, use, or misuse of the promotion prize or any element thereof.

Odds

The odds of winning a prize in the Cash Prizes are Coming to Town promotion will vary depending on the number of entries.

Iowa Lottery Chief Executive Officer's Discretion

If the Iowa Lottery Chief Executive Officer (CEO), or the CEO's designee, determines that an otherwise valid entry has been foiled by the intervention of an Iowa Lottery employee, Iowa Lottery retailer, or Iowa Lottery vendor processing error, the CEO may authorize the replacement of an eligible entry. This shall be the player's only recourse against the Iowa Lottery or its personnel.

Force Majeure

If the lowa Lottery is hindered from providing the prizes due to riots, acts of God, shortages of labor or materials, war, acts of terrorism, governmental laws, regulations, or restrictions or any other causes of any kind whatsoever which are beyond the reasonable control of the lowa Lottery, then the lowa Lottery, the lowa Department of Revenue, and the State of lowa shall not be liable or responsible for its inability to provide some or all of the prizes discussed herein.

Choice of Law and Forum

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court for the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Iowa Lottery, the Iowa Department of Revenue, or the State of Iowa.
