Dublin Your Luck Football Promotion Rules

The Dublin Your Luck Football promotion is an IA Lottery VIP Club[™] web-based Play It Again[®] promotion offering a football experience prize package for the Cyclone[™] football 2025 season opener in Dublin, Ireland. The promotion, which can be entered by members of the VIP Club with eligible \$5 Cyclone[™] scratch tickets (Game #711), begins at 10:00 a.m. Central Time (CT) on Monday, December 2, 2024, and its entry period ends at 9:59 a.m. CT on Monday, February 10, 2025.

The Dublin, Ireland Experience Prize Package for two includes round-trip economy flight from Des Moines International Airport to Dublin Airport; airport transfer via motorcoach in Dublin; five-night stay at The Morgan Hotel Dublin with checkin on August 20, 2025; access to an exclusive Iowa State Welcome event with Cyclone fans; a sightseeing city card with free entry to some of Dublin's top attractions; hop-on, hop-off bus ticket; two football game tickets for the Iowa State vs. Kansas State season opener on August, 23, 2025; co-branded Iowa Lottery/Iowa State jackets and duffle bags; exclusive commemorative gifts and credentials; \$5,000 spending money (paid via check); and the state and federal required income tax withholding paid on behalf of the winner.

The Dublin Your Luck promotion prize is subject to lottery rules, validation procedures, set-offs and deductions authorized by law. The Dublin Your Luck prize package includes the required state and federal income tax withholding paid on the value of the prize package. There is no all-cash option for the prize package. The winner is responsible for all other taxes that may be due and owing.

Entry

To enter, an individual must be a current member of or join the IA Lottery VIP Club. Entrants must legally acquire and submit a nonwinning \$5 Cyclone (Game #711) scratch ticket. Individuals enter the promotion as follows: During the eligibility period, entrants log in to their VIP Club account on the Iowa Lottery website, ialottery.com, to enter the promotion. On the Iowa Lottery website, ialottery.com, entrants will manually enter the scratch ticket numbers (located on the front of the ticket in the scratch-off area and the back of the ticket). Entrants can also scan and enter the eligible \$5 Cyclone scratch tickets with the Iowa Lottery LotteryPlus mobile app.

Each nonwinning \$5 Cyclone scratch ticket entered will receive one entry in the promotion drawing. Players may enter multiple \$5 Cyclone scratch tickets, but each eligible ticket can be entered only once. All entries are final. Entrants must follow the VIP Club rules. Players must use a street address for their account information – P.O. boxes are not valid for this promotion or the VIP Club.

Eligibility

An eligible entry is any legally acquired nonwinning \$5 Cyclone (Game #711) scratch ticket that has not been previously submitted on the Iowa Lottery LotteryPlus app or through the Iowa Lottery website as an entry into this promotion or any previous promotion. All entrants must be 21 years of age or older.

Except as provided under the "lowa Lottery Chief Executive Officer's Discretion" section below, an eligible entry is one in which the entry information is completed and submitted electronically during the posted entry time, as specified on the lowa Lottery website. Players may attempt to enter or submit up to 40 total entries per day in a VIP Club account. Each attempt of ticket submission counts as one entry attempt. The lowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. February 10, 2025.

The winner of the Cyclone Football Promotion Dublin, Ireland Experience prize package from the November 21, 2024 drawing is not eligible to win the Dublin Your Luck experience prize package. Players who have signed up for the Iowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the Iowa Lottery Commission, Iowa Lottery employees, Iowa Department of Revenue staff who support the Lottery Division, and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the Iowa Lottery, and their immediate families, as defined by statute, are not eligible.

Drawings

The lowa Lottery drawing for the Dublin Your Luck promotion will be held on Tuesday, February 11, 2025. The lowa Lottery drawing will be held in accordance with the schedule posted to the lowa Lottery's website (ialottery.com) and listed in the Dublin Your Luck promotion rules.

The drawing will drawing will be held under the supervision of an independent auditor. All drawings of the lowa Lottery are public events and the lowa Lottery will comply with any public health directives in effect at the time of these drawings. Persons interested in observing drawings are invited to receive detailed information by contacting the lowa Lottery Security Division by telephone at (515) 725-7900, by TTY Relay lowa at (800) 735-2942, or by email directed to WMaster@ialottery.com. A request to observe a drawing must be received by the lowa Lottery no later than seven days in advance of the drawing. All drawings are recorded.

The winners' name will be posted on the lowa Lottery's website by the end of the day following the draw day or as soon as practicable following the determination of the winner. The winner will be sent an email to their VIP Club member email address. Entrants are not required to personally attend the drawing or be present at the time of the drawing to win. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prize to be announced and awarded.

In order to claim their prize, the winner must complete and sign an Iowa Lottery Winner Claim Form, along with appropriate tax documentation, and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery by the claim deadline. The winner may present the completed documents at any Iowa Lottery regional office open Monday through Friday from 8:00 a.m. to 4:00 p.m., through the Iowa Lottery's digital promotion prize claim process, or by mail to the Iowa Lottery headquarters office at 13001 University Avenue, Clive, IA 50325. Iowa Lottery offices are closed on weekends and state holidays. The claim deadline is 4 p.m. February 25, 2025.

If the valid winner of the Dublin Your Luck prize package does not present a fully executed Iowa Lottery Winner Claim Form and the appropriate documents to the Iowa Lottery by the claim deadline, the prize will be awarded to the next valid entrant in the order drawn. If an alternate(s) is required for the prize package, an email notification will be sent to the alternate's VIP Club email address and their name will be posted on the Iowa Lottery website and mobile app. If an alternate(s) is required for a Dublin Your Luck prize package, they must present a fully executed Iowa Lottery Winner Claim Form and required documents to the Iowa Lottery by 4:00 p.m. on the deadline date listed in the notification email.

By submitting an entry into the Dublin Your Luck promotion and claiming the prize, the entrant certifies they are the owner of the entry, the entrant is at least 21 years old, the ticket was not stolen or acquired illegally, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the lowa Lottery, the lowa Department of Revenue, and the State of lowa, its elected officials, apprentices, employees, agents, and volunteers. In consideration for participating in the promotion, the entrant waives any and all claims the entrant may have or ever claim to have against the lowa Lottery, the lowa Department of Revenue, and the State of lowa, its employees, agents, or commission members, relating in any way to the promotion. The player also consents to the use by the lowa Lottery and the lowa Department of Revenue of their name or likeness for advertising, trade or promotional purposes without further compensation.

By accepting the Dublin Your Luck promotion prize, the winner and their heirs, legal representatives, and assigns agree to indemnify, defend, release, and discharge the lowa Lottery, the lowa Department of Revenue, and the State of lowa, and each of their employees, officers, and directors from and against any loss, claim damage, suit, or injury arising out of or relating to the promotion or any action taken pursuant to these rules. The lowa Lottery, lowa Department of Revenue, and the State of lowa are not responsible or liable, in any way, for any personal injuries, illness, death, property damage, or other damages or expense resulting from or arising out of acceptance, fulfillment, use, or misuse of the promotion prize or any element thereof.

Odds

The odds of winning the Dublin Your Luck promotion prize will vary depending on the number of entries.

Iowa Lottery Chief Executive Officer's Discretion

If the lowa Lottery Chief Executive Officer (CEO), or the CEO's designee, determines that an otherwise valid entry has been foiled by the intervention of an lowa Lottery employee, lowa Lottery retailer, or lowa Lottery vendor processing error, the CEO may authorize the replacement of an eligible entry. This shall be the player's only recourse against the lowa Lottery or its personnel.

Force Majeure

If the lowa Lottery is hindered from providing the prizes due to riots, acts of God, shortages of labor or materials, war, acts of terrorism, governmental laws, regulations, or restrictions or any other causes of any kind whatsoever which are beyond the reasonable control of the lowa Lottery, then the lowa Lottery, the lowa Department of Revenue, and the State of lowa shall not be liable or responsible for its inability to provide some or all of the prizes discussed herein.

Choice of Law and Forum

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court for the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Iowa Lottery, the Iowa Department of Revenue, or the State of Iowa.

Technical Disclaimer

The lowa Lottery, the lowa Department of Revenue, and the State of lowa are not responsible for and shall not be liable for:

- Any damage to an entrant's computer system or device that is directly or indirectly caused by accessing or downloading content from https://www.ialottery.com or otherwise participating in this promotion; or
- Any computer system, phone line, hardware, software, cell phone, application, or program malfunctions; or
- Other errors, failures, dropped or delayed computer transmissions or network connections that are human or technical in nature.

Without limiting the generality of the foregoing, the lowa Lottery, the lowa Department of Revenue, and the State of lowa are not responsible for incomplete, illegible, misdirected, late, lost, damaged, or stolen entries; lost, interrupted, inaccessible, or unavailable networks, satellites, Internet Service Providers (ISPs), websites, or other connections; miscommunications; failed, jumbled, scrambled, delayed, or misdirected computer, telephone, or cable transmissions; or any technical malfunctions, failures, or difficulties; printing errors; clerical, typographical, or other errors in the offering or announcement of any prize or in any prize notification documents; the incorrect or inaccurate capture of information or the failure to capture information; or other errors of any kind or nature.
