

**Iowa Lottery Audience Member Drawing
Grand Concourse at the Iowa State Fair
Thursday, August 8, 2024**

The Iowa Lottery is holding a special prize promotion Audience Member Drawing during the Cash Fever Game Show live event on Thursday, August 8, 2024, opening day of the 2024 Iowa State Fair.

To be one of the 1,200 people eligible for the drawing, Fairgoers at least 21 years of age or older must register for the drawing and be present during the Cash Fever Game Show to be held at 5:30 p.m. on the Grand Concourse in front of the Fair Administration Building. Fairgoers must be in attendance in the audience at the live drawing event for a chance to win a \$5,000 or \$50,000 prize. Fairgoers should look for the Iowa Lottery's logo tent on the Grand Concourse beginning at 2:00 p.m. on August 8, 2024, to register to be one of the eligible Audience Members for the drawing and get a \$5 Iowa State Fair scratch ticket at no cost.

There will be three cash prizes awarded and announced in the Audience Member Drawing: two prizes of \$5,000 and one prize of \$50,000.

Audience Member Prizes:

- Two (2) prizes of \$5,000
- One (1) prize of \$50,000

ENTRY

To enter the drawing, an individual must register for the Audience Member Drawing at the stage area of the Iowa Lottery's Cash Fever Game Show on the Grand Concourse in front of the Fair Administration Building on the Iowa State Fairgrounds. Beginning at 2:00 p.m. August 8, Fairgoers 21 and older can fill out an entry form, proceed to a table where they will present their government-issued photo ID to a Lottery representative, receive an Iowa State Fair scratch ticket at no cost and get their hand stamped. After the Lottery representative has verified that the person is at least 21, the Fairgoer will place the entry form into a drawing container, the person will receive an information sheet advising that they may leave the registration/game show area to enjoy the Fair; however, the person must return and be present by 5:30 p.m. for the live Cash Fever Game Show for a chance to win an Audience Member prize.

The registration process will take place on from 2:00 p.m. to 4:00 p.m. August 8, 2024, or until 1,200 Audience Members have been registered, whichever occurs first. The Lottery at its discretion may decide to continue registration at a table until 5:00 p.m. or when 1,200 registration are achieved, whichever occurs first. Only one entry per person. All entries are final.

ELIGIBILITY

An eligible entry is a completed and valid entry form that is placed in the drawing container during the registration period for Audience Members prior to the start of the Cash Fever Game Show live event. To win a prize, Audience Members must be present at the drawing during the Cash Fever Game Show live event.

Except as provided under the "Iowa Lottery Chief Executive Officer's Discretion" section below, an eligible entry is one in which the entry information is completed and placed in the drawing drum during the event, as specified in these rules and posted on the Iowa Lottery website. Fairgoers may enter only once. The Iowa Lottery is not responsible for entries that are made inaccurately, incorrectly, or arrive after the 1,200 entrants are registered on August 8, 2024.

Players who have signed up for the Iowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the Iowa Lottery Commission, Iowa Lottery employees, Iowa Department of Revenue staff who support the Lottery Division, and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the Lottery, and their immediate families, as defined by statute, are not eligible.

DRAWING

The Iowa Lottery Audience Member Drawing will be held during the Cash Fever Game Show live event scheduled to begin at 5:30 p.m. on Thursday, August 8, 2024. The drawing will be held in accordance with the schedule posted to the Iowa Lottery's website (ialottery.com) and listed in the Audience Member Drawing promotion rules.

The drawing will be held under the supervision of an independent auditor and Iowa Lottery security. All drawings of the Iowa Lottery are public events and the Lottery will comply with any public health directives in effect at the time of these drawings. The Audience Member winner names will be announced by a Lottery Official during the Cash Fever Game Show event. Winners must be present to win and identify themselves to Lottery representatives within 2 minutes of their name being announced at the live event. The Lottery will make a maximum of three attempts to select winners for each of the three Audience Member cash prizes.

In order to claim their prize, winners must complete and sign an Iowa Lottery Winner Claim Form, along with appropriate tax documentation, and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery by

August 23, 2024. The winners may complete the documents at the drawing on August 8, 2024, or through the Iowa Lottery's digital promotion prize claim process.

Audience Member Drawing promotion prizes are subject to lottery rules, validations procedures, set-offs and deductions authorized by law. Winners are responsible for all other taxes that may be due and owing.

If a valid winner of an Audience Member Drawing prize does not present a fully executed Iowa Lottery Winner Claim Form and the appropriate documents to the Iowa Lottery by the claim deadline, the prize will be forfeited.

FORCE MAJEURE

If the Iowa Lottery is hindered from conducting the Audience Member Drawing or providing the prizes due to riots, acts of God, shortages of labor or materials, war, acts of terrorism, governmental laws, regulations, or restrictions or any other causes of any kind whatsoever which are beyond the reasonable control of the Iowa Lottery, then the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa shall not be liable or responsible for its inability to provide some or all of the prizes discussed herein. The Iowa Lottery reserves the right to terminate or modify the drawing in its sole discretion to be equitable and fair for all eligible entries received prior to the cancellation or termination of the drawing.

If inclement weather forces a change in location of the Cash Fever Game Show live event, the Iowa Lottery at its discretion may reduce the number of registered audience members that are eligible for the drawing.

CHOICE OF LAW AND FORUM

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court for the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Iowa Lottery, the Iowa Department of Revenue, or the State of Iowa.

DISCLAIMER

The Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa are not responsible for and shall not be liable for:

- Any person who is not one of the first 1,200 registered entrants for the Audience Member Drawing; or
- Any person who is not present during the drawing or doesn't hear their name announced as a winner; or
- Other errors, failures, dropped or program malfunctions that are human or technical in nature.

Without limiting the generality of the foregoing, the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa are not responsible for incomplete, illegible, misdirected, late, lost, damaged, or stolen entries; or other errors in the offering or announcement of any prize; the incorrect or inaccurate capture of information or the failure to capture information; or other errors of any kind or nature. In no event shall the Iowa Lottery, the Iowa Department of Revenue, or the State of Iowa be liable for any claims or liabilities arising out of the person's participation in the Audience Member Drawing.

Caution: Any attempt to deliberately damage any website related to the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa or to undermine the legitimate operation of the promotion may be in violation of criminal and civil laws and will result in disqualification if the individual is an entrant. If such an attempt is made, the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa reserve the right to seek remedies and damages from any such person to the fullest extent of the law, including criminal prosecution. The Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa, in each entity's sole discretion, reserve the right to cancel the promotion if the systems or equipment through which the promotion is operated has become corrupted or if the integrity of the promotion has in any way been compromised.
