

Bonus Basketball Promotion Rules

The Bonus Basketball Promotion is an Iowa Lottery VIP Club web-based promotion offering 10 Timberwolves VIP Suite experience prize packages with basketball tickets to the Minnesota Timberwolves vs the Golden State Warriors game on Sunday, March 24, 2024, along with courtside tickets to Iowa Wolves home basketball games in Des Moines. There will be nine winners of a prize package with 2 suite tickets to the Timberwolves vs Golden State Warriors game in Minneapolis, Minnesota; a bonus of 2 Iowa Wolves courtside seat tickets to a home game in Des Moines, Iowa; and \$1,000 spending money. There also will be one winner of a Last Shot prize package with 2 suite tickets to the Timberwolves vs Golden State Warriors game in Minneapolis, Minnesota, and \$1,500 cash. Players will pick the Iowa Wolves game of their choice when they make a promotion entry.

The promotion, which can be entered by members of the VIP Club with eligible \$10 Bonus Multiplier scratch tickets, begins at 10:00 a.m. Central Time (CT) on Friday, January 5, 2024, with entries accepted through 9:59 a.m. Central Time (CT) on Wednesday, March 6, 2024. There are three entry deadlines for the prize packages involved and three draw dates in the promotion. The drawings will be held on January 25, 2024; February 22, 2024; and March 7, 2024.

*All entries that were not selected in one of the three initial prize package category drawings will be automatically entered into the Last Shot prize package drawing.

The Bonus Basketball promotion prizes are subject to lottery rules, validation procedures, set-offs and deductions authorized by law. The Iowa Lottery will withhold all state and federal taxes as may be required by law. Winners are responsible for all other taxes that may be due and owing.

Entry

To enter, individuals must be a current member or join the Iowa Lottery VIP Club. Entrants must legally acquire and submit a nonwinning Bonus Multiplier scratch ticket, Game #674 as follows: During the eligibility period, entrants can scan and enter their eligible Bonus Multiplier scratch tickets with the Iowa Lottery LotteryPlus mobile app or enter the Bonus Multiplier scratch ticket numbers (located on the front of the ticket in the scratch-off area and the back of the ticket) on the Iowa Lottery website at ialottery.com. Players can enter Bonus Multiplier scratch tickets into the promotion beginning at 10 a.m. January 5, 2024. Players will select the prize category of the player's choice for the Iowa Wolves home games from February 3, 2024, through March 30, 2024. Each nonwinning Bonus Multiplier scratch ticket entered will receive one entry in the promotion category of the player's choice.

Players may enter multiple Bonus Multiplier scratch tickets, but each eligible scratch ticket can be entered only once. While a VIP Club member can enter multiple times during the promotion, each VIP Club member can win only one prize in the Bonus Basketball promotion. Entries do not carry over from one drawing to the next except that all Bonus Multiplier scratch ticket entries submitted during the Bonus Basketball promotion that were not selected as a winner in a category drawing for a Timberwolves VIP Suite and Bonus Iowa Wolves Courtside Seats Prize Package will be eligible for the Last Shot Prize Package Drawing.

Eligibility

An eligible entry is any legally acquired nonwinning Bonus Multiplier scratch ticket that has not been previously submitted on the Iowa Lottery LotteryPlus app or through the Iowa Lottery website as an entry into this promotion.

Except as provided under the "Iowa Lottery Chief Executive Officer's Discretion" section below, an eligible entry is one in which the entry information is completed and submitted electronically during the posted entry time, as specified on the Iowa Lottery website. Players may attempt to enter or submit up to 40 total entries per day in their VIP Club account. Each attempt of ticket submission counts as one entry attempt. The Iowa Lottery is not responsible for otherwise eligible entries that are entered inaccurately, incorrectly, or arrive after 9:59 a.m. March 6, 2024. All entrants must be 21 years of age or older. Players may only win one Bonus Basketball prize package during the promotion.

Players who have signed up for the Iowa Lottery self-exclusion program are not eligible to participate in this promotion. Members of the Iowa Lottery Board of Directors, Iowa Lottery employees, Iowa Department of Revenue staff who support the Lottery Division, and their immediate families, as defined by statute, are not eligible. Further, officers, employees, agents, or subcontractors of any vendor who have access to confidential information that may compromise the integrity of the Lottery, and their immediate families, as defined by statute, are not eligible.

Drawings

The drawings for the Bonus Basketball promotion will be held on Thursday, January 25, 2024; Thursday, February 22, 2024; and Thursday, March 7, 2024. The Iowa Lottery drawings will be held in accordance with the schedule posted to the Iowa Lottery's website (ialottery.com) and listed in the rules.

The drawings will be held under the supervision of an independent auditor. All drawings of the Iowa Lottery are public events and the Lottery will comply with any public health directives in effect at the time of these drawings. Persons interested in observing drawings are invited to receive detailed information by contacting the Iowa Lottery Security Division by telephone at (515) 725-7900, by TTY Relay Iowa at (800) 735-2942, or by email directed to WMaster@ialottery.com. A request to observe a drawing must be received by the Iowa Lottery no later than seven days in advance of the drawing. All drawings are recorded.

The winners' names will be posted on the Lottery's website by the end of the day following the draw day or as soon as practicable following the determination of the winners. Each winner will be sent an email to his or her VIP Club member email address. Entrants are not required to personally attend the drawing or be present at the time of the drawing to win. Each of the selected numbers will be verified against the numbers entered in the promotion. A sufficient number of entries will be randomly selected to ensure there are valid winners for the prizes to be announced.

In order to claim their prize, winners must complete and sign an Iowa Lottery Winner Claim Form, along with appropriate tax documentation, and present those documents with a legible copy of their government-issued photo identification to the Iowa Lottery by 4 p.m. on the claim deadline date. Winners may present the completed documents at any Iowa Lottery regional office open Monday through Friday from 8:00 a.m. to 4:00 p.m., through the Iowa Lottery's digital promotion prize claim process, or by mail to the Iowa Lottery headquarters office at 13001 University Avenue, Clive, IA 50325. Lottery offices are closed on weekends and state holidays.

January 25, 2024 drawing date: The claim deadline is 4:00 p.m., Thursday, February 1, 2024.

February 22, 2024 drawing date: The claim deadline is 4:00 p.m., Friday, March 1, 2024.

March 7, 2024 drawing date: The claim deadline is 4:00 p.m., Thursday, March 14, 2024.

If a valid winner of a Bonus Basketball prize package does not present a fully executed Iowa Lottery Winner Claim Form and the appropriate documents to the Iowa Lottery by the claim deadline, the prize will be awarded to the next valid entry in the order drawn. If an alternate(s) is required for a prize package, an email notification will be sent to the alternate's VIP Club email address and their name will be posted on the Iowa Lottery website and mobile app. If an alternate(s) is required for a Bonus Basketball prize package, they must present a fully executed Iowa Lottery Winner Claim Form and required documents to the Iowa Lottery by 4:00 p.m. CT on the deadline date listed in the notification email.

By submitting an entry into the Bonus Basketball promotion and claiming the prize, the entrant certifies they are the owner of the entry, the entrant is at least 21 years old, the ticket was not stolen or acquired illegally, and the entrant is not disqualified from receiving a prize. By entering the promotion, the entrant agrees to indemnify and hold harmless the State of Iowa, Iowa Department of Revenue, and the Iowa Lottery, its elected officials, apprentices, employees, agents, and volunteers. In consideration for participating in the promotion, the entrant waives any and all claims the entrant may have or ever claim to have against the State of Iowa, Iowa Department of Revenue, or the Iowa Lottery, its employees, agents, or board members, relating in any way to the promotion. The player also consents to the use by the Lottery of their name or likeness for advertising, trade or promotional purposes without further compensation.

By accepting a Bonus Basketball promotion prize, the winner and their heirs, legal representatives, and assigns agree to indemnify, defend, release, and discharge the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa, and each of their employees, officers, and directors from and against any loss, claim damage, suit, or injury arising out of or relating to the promotion or any action taken pursuant to these rules. The Iowa Lottery, Iowa Department of Revenue, and the State of Iowa are not responsible or liable, in any way, for any personal injuries, illness, death, property damage, or other damages or expense resulting from or arising out of acceptance, fulfillment, use, or misuse of the promotion prize or any element thereof.

Odds

The odds of winning a Bonus Basketball promotion prize will vary depending on the number of entries.

Iowa Lottery Chief Executive Officer's Discretion

If the Iowa Lottery Chief Executive Officer (CEO), or the CEO's designee, determines that an otherwise valid entry has been foiled by the intervention of an Iowa Lottery employee, Iowa Lottery retailer, or Iowa Lottery vendor processing error, the CEO may authorize the replacement of an eligible entry. This shall be the player's only recourse against the Iowa Lottery or its personnel.

Force Majeure

If the Iowa Lottery is hindered from providing the prizes due to riots, acts of God, shortages of labor or materials, war, acts of terrorism, governmental laws, regulations, or restrictions or any other causes of any kind whatsoever which are beyond the reasonable control of the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa shall not be liable or responsible for its inability to provide some or all of the prizes discussed herein.

Choice of Law and Forum

The laws of the State of Iowa shall govern and determine all matters arising out of or in connection with this promotion. Any and all litigation commenced in connection with this promotion shall be brought and maintained solely in Polk County District Court for the State of Iowa, Des Moines, Iowa, or in the United States District Court for the Southern District of Iowa, Central Division, Des Moines, Iowa, wherever jurisdiction is appropriate. This provision shall not be construed as waiving any immunity in state or federal court, which may be available to the Iowa Lottery, the Iowa Department of Revenue, or the State of Iowa.

Technical Disclaimer

The Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa are not responsible for and shall not be liable for:

- Any damage to an entrant's computer system or device that is directly or indirectly caused by accessing or downloading content from <https://www.ialottery.com> or otherwise participating in this promotion; or
- Any computer system, phone line, hardware, software, cell phone, application, or program malfunctions; or
- Other errors, failures, dropped or delayed computer transmissions or network connections that are human or technical in nature.

Without limiting the generality of the foregoing, the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa are not responsible for incomplete, illegible, misdirected, late, lost, damaged, or stolen entries; lost, interrupted, inaccessible, or unavailable networks, satellites, Internet Service Providers (ISPs), websites, or other connections; miscommunications; failed, jumbled, scrambled, delayed, or misdirected computer, telephone, or cable transmissions; or any technical malfunctions, failures, or difficulties; printing errors; clerical, typographical, or other errors in the offering or announcement of any prize or in any prize notification documents; the incorrect or inaccurate capture of information or the failure to capture information; or other errors of any kind or nature.

Caution: Any attempt to deliberately damage any website related to the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa or to undermine the legitimate operation of the promotion may be in violation of criminal and civil laws and will result in disqualification if the individual is an entrant. If such an attempt is made, the Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa reserve the right to seek remedies and damages from any such person to the fullest extent of the law, including criminal prosecution. The Iowa Lottery, the Iowa Department of Revenue, and the State of Iowa, in each entity's sole discretion, reserve the right to cancel the promotion if the system through which the promotion is operated has become technically corrupted or if the integrity of the promotion has in any way been compromised.
